**NOTIFICATION**

**SEF/PSDU/055/2021:** In compliance with the notification of School Education & Literacy Department vide NO.SO(A&T)SELD/9(3)/2020 dated 9<sup>th</sup> October 2021, pursuant to the decisions of NCOC meeting held on 07-10-2021 and with the approval of the Competent Authority, keeping in stock of the COVID-19 situation, corresponding reduction in critical care occupancy and need to accelerate students vaccination, following are hereby notified for strict compliance:

- (i) All the Foundation Assisted Schools (FAS) and Centers shall be allowed 100% attendance of students / learners with effect from 11<sup>th</sup> October, 2021.
- (ii) The vaccination of students of the ages of 12 years and above is obligatory. Therefore, all the regional & district Heads of the Foundation and the partners will make necessary effort for 100% vaccination of the students of ages 12 years and above till 31<sup>st</sup> October 2021 in coordination with the concerned Directorates of Schools and the office of Director General, Inspection & Registration of Private Educational Institutions, Sindh.
- (iii) The SEF District Monitoring Committee, notified earlier for field monitoring of COVID-19 SOPs, are instructed to randomly visit schools and check for compliances. Moreover, an administrative team of the SE&LD may be visiting the schools/centers and if any eligible student is found un-vaccinated during random visits of such team, action will be initiated against the school administration.
