**SUBJECT:** 

FUNCTIONALIZATION OF FOUNDATION ASSISTED SCHOOLS/ CENTERS IN SINDH.

It is notified that all the Foundation Assisted Schools/Centers shall remain open subject to the following conditions where the Partners shall ensure safety/security of electricity supply/wiring as well as ensure availability of clean drinking water and sanitation arrangements:

1. Schools/Centers NOT affected by the rains / floods

1.1 Foundation Assisted Schools/Centers which have not been affected by the calamity of monsoon rain/floods shall remain open/functional across Sindh.

2. Schools/Centers ONLY PARTIALLY affected by the rains / floods

2.1 Foundation Assisted Schools/Centers which have been affected but have not sustained major damage may be functionalized across all the regions after necessary repairs.

2.2 The schools considered fit/suitable for resumption of classes by the Partners must ensure the provision of all basic facilities.

3. Schools/Centers DESTROYED / DAMAGED by the rains / floods

- 3.1 For the Foundation Assisted Schools/Centers which have been extensively damaged OR submerged OR destroyed, a temporary setup in a nearby area of these schools/centers may be initiated to resume teaching/learning activities subject to the ground conditions.
- 3.2 For the abovementioned schools, routine classes may resume after getting a Fitness Certificate from Pakistan Engineering Council (PEC) registered civil engineer / civil engineering firm. These certificates shall be submitted to concerned District Office.
- 4. Schools/Centers occupied by / declared shelters for INTERNALLY DISPLACED PERSONs (IDPs)
- 4.1 For the schools which have been occupied by the IDPs or declared shelters for IDPs, the Partners may establish 'Tent Schools/Centers' at or nearby such schools OR initiate temporary setups. The Partners of these schools shall submit the status report to concerned District Office.
