SUBJECT: SUBMISSION OF ONLINE APPLICATION FOR REGISTRATION AND RENEWAL OF REGISTRATION OF PRIVATELY MANAGED SCHOOLS.

This is with reference to circular No. DIR/I&R/PIS/EDU/GOS (5243-45)/2022 issued on dated 1st November 2022 by the Directorate of Inspection & Registration of Private Institutions Sindh on the subject notified above. SE&LD has digitized the process of submission of applications on Form 'A' for the purpose of registration and renewal of registration of all privately managed educational institutions in the month of July 2019. Accordingly, Directorate (DIRPIS) vide Circular no. DIR/I&R/PIS/EDU/GOS(6654-65)/2019, dated 15th July 2020, directed the administration/principals of all privately managed schools to apply for the registration and renewal of the registration online and also upload all relevant information of the school on www.direprivateschools.gos.pk.

- It is further added that Sindh Education Foundation has clearly stated in Article 2: Administrative Fundamentals and Learning Environment and Clause 2.1 School Registration which reads as follows;
 - "Partner shall register the school with the concerned authorities and must submit the credentials to the Foundation. Partner must initiate the registration process of school(s) within 45 days."
- 3. Directorate (DIRPIS) has upgraded the system for submission of applications for registration/renewal of registration, therefore, all Partners (whose schools are not registered yet or whose registration is to be renewed) are hereby directed through this letter to submit the said application online only on the Directorate website mentioned above. Hard copies of the application and relevant documents (file) must be submitted to the Directorate after submission of the online application.
- 4. The concerned partners must ensure compliance in this regard and report the status to the concerned District Office of Sindh Education Foundation.
